**INSTRUCTIONS** - Provide us a minimum of 5 Saturdays from May 25th thru July 20th for your Home matches.

All matches, except for the last championship match, are played on Saturdays during the season, with the tee times beginning at 1 p.m. About half of your matches will be "away," the rest will be at "home".

Saturday practice matches will be the responsibility of each club to schedule and coordinate directly between the coaches/clubs.

Since we have only 9 weeks to complete 6 matches, it is vitally important that you give us as many Home dates as possible for our scheduling flexibility. This will also enable the schedule makers to avoid holiday weekends if possible.
